#### Squatted Trucks are Illegal?

Whether you call them squatted trucks, tooted trucks, or "Carolina Squat," drivers of these custom trucks may be subject to fines and license suspensions if caught cruising in certain states.

After May 10, South Carolina Squat truck owners will be subject to fines and potential loss of license if caught driving on public roads. First time offenders will receive a \$100 fine, but if caught a second time, the fine increases to \$200. A third offense will be rewarded with a \$300 fine and a year-long license suspension.

Similar to cars sporting the California lean, the squatted truck modification refers to an aesthetic change involving installing a sizable front lift kit while the rear is lowered or left stock, which results in a reverse rake. However, the South Carolina law also includes the reverse, when a vehicle is lower in the front and lifted in the rear.

The main reason why squatted trucks are banned is for safety concerns, for both the owner and other drivers on the road. Lifting a vehicle in the front and aiming it toward the sky compromises the driver's view, making it difficult to see over the dash. It can be difficult to see squatted trucks on the road at night because the headlights are aimed upward, which also impacts how much the driver can see. Since the truck is lifted in the front, it changes the contact point of the bumper in the event of a collision. (click picture for link)



On July 1st, operating a "squatted" truck on Georgia roadways became illegal, joining at least ½ dozen other states. Georgia OCGA 40-8-6 and 40-8-6.1 highlight that any vehicle weighing between 4000 lb and not more than 7500 lb is restricted from elevating or lowering the frame height more than four inches above or below the frame of the rear of the vehicle. It also establishes that a vehicle lift can be no more than six inches above or below the manufacturer's recommendation.



## Samsung's EV battery breakthrough: 600-mile charge in 9 mins, 20 year lifespan

Given the current high production costs, the initial adoption of these batteries will be confined to the "super premium" EV segment.

Samsung recently made a splash in the industry by showcasing its recent advancements in battery technology, especially related to solid-state batteries.

At the SNE Battery Day 2024 expo in Seoul, South Korea, the company revealed that its pilot solid-state battery production line is now fully operational. "We built a pilot line last year to mass-produce all-solid-state batteries by 2027," said Samsung SDI, as reported by *The Elec*. Moreover, the battery's initial batches have already been delivered to EV manufacturers for testing.

"We supplied samples to customers from the end of last year to the beginning of this year and are receiving positive feedback," Samsung SDI stated. Notably, these batteries could power electric vehicles with a 600-mile range, charge in 9 minutes, and have a lifespan of 20 years. These solid-state batteries are expected to be smaller, <u>lighter</u>, and safer than the lithium-ion batteries currently used in most electric vehicles. They hold significant potential to revolutionize the EV industry.

"All-solid-state batteries can enhance safety by replacing liquid components with solid ones. When used in the same pack size as existing products, they reduce weight and take up less space," highlighted the company. However, due to their high production costs, these batteries' initial application will be limited to the "super premium" EV segment. The "super premium" segment here implies a driving range of around 600 miles per charge. In

addition, Samsung will be introducing high-nickel NCS products for the premium segment.

Samsung's oxide <u>solid-state battery</u> technology boasts an energy density of 500 Wh/kg, nearly double the 270 Wh/kg density of mainstream EV batteries. This increased density could potentially double the driving range of current electric vehicles.

Besides, Samsung's claim of 9-minute charging likely refers to the standard metric of charging a battery from 10% or 20% to 80% capacity rather than a full charge from 0% to 100%. This practice is common in the industry as charging speeds typically slow down significantly beyond the 80% mark to protect battery health and longevity.

In addition to its work on solid-state batteries, Samsung is developing more affordable lithium iron phosphate (LFP) and cobalt-free batteries, as well as a dry electrode production method to reduce costs. "We will not only match the price in the popular and entry-level segments, but also mass produce products that can be rapidly charged in 9 minutes by 2026," emphasized Samsung SDI.

That said, limited availability of charging infrastructure remains a significant hurdle. While some Chinese battery makers already offer 5C or 6C charging speeds, equivalent to 480kW and even 600kW charging stations, they are quite few in numbers.

However, notable is the visible approach of all battery makers to offer longer lifespans of batteries. CATL and other battery makers have already announced batteries with 20-year lifespans, often referred to as "million-mile" batteries. Samsung's vision to "extend the battery life to 20 years" aligns with the broader market trend.

While Samsung's solid-state battery progress is significant, the company must navigate a competitive landscape dominated by Chinese manufacturers.

Editorial Note: No, I don't expect everyone to understand everything in this article. If you do, that's great. (I don't and I'm supposed to be an electrical engineer.) But the point is simple. In my opinion, the main things holding back EVs is the range (if this is my only car), the lack of readily available charging stations, and the time it takes to recharge on the highway. New technologies in battery capacity and charging times, as promised above, clicks off two of those boxes. The developments are still in the future, and the infrastructure isn't available to dump that amount of charge, in 9 minutes, into a vehicle on the highway. But isn't it exciting to think the technology is getting close to the point where we could drive from here to Savannah and back again on one charge! And as the range gets extended to these distances, it is possible that highway charging stations won't be needed! You'll be able to get home before you need your next charge. Just a little food for thought.

## Tesla Ordered to Fix Air Quality Violations at Fremont, CA, Factory



The Bay Area Air Quality Management District has come up with a two-step process for Tesla to address more than 110 notices of violations at the factory.

*Tesla* has been mandated by the Bay Area Air Quality Management District (BAAQMD) to rectify "ongoing air quality violations" at its Fremont Factory in Northern California, to curb the frequent and significant emissions issues linked to the factory's paint shop operations.

The BAAQMD issued an abatement order June 25 to halt the persistent violations. The agency said Tesla has accumulated more than 110 notices of violations related to air quality since 2019. Each of these violations has the potential to emit hundreds of pounds of illegal air pollution, posing risks to public health and the environment.

"Tesla's ongoing violations at their Fremont facility pose a risk to public health and air quality in the surrounding community," said Dr. Philip Fine, executive officer of the BAAQMD. "This order is crucial to ensure that Tesla takes prompt and effective action to

stop harmful emissions and comply with all air quality regulations to protect the health of those living near the facility."

Some of the violations stem from breakdowns in the factory's thermal oxidizer or other components of the abatement system, leading to periods where emissions are vented directly into the atmosphere without proper treatment. Additionally, Tesla has manually shut down the abatement system during equipment issues in the paint shop, exacerbating the problem.

To address these issues, the BAAQMD has outlined a two-step process for Tesla. First, the company must hire a third-party consultant to evaluate the situation and provide recommendations. Tesla must then develop and submit an implementation plan based on these recommendations to the hearing board for approval. Second, Tesla must execute the approved plan to prevent the avoidable release of uncontrolled emissions, except in cases where it is necessary for safety reasons.

This is not the first instance of air quality concerns at Tesla's <u>Fremont Factory</u>. In May 2021, Tesla agreed to pay a \$1 million fine and install a solar roof project on top of the production plant as part of a settlement with the BAAQMD after 33 violations were identified.
